#### EYE PROTECTION ADAPTED TO YOUR EYESIGHT



#### **HSQWL TELEPHONE LINE**

Since February 8<sup>th</sup>, 2021, the operating hours of the HSQWL telephone line (1 833 755-0668) are from 8:00 a.m. to 4:00 p.m., Monday through Friday, and from 8:00 a.m. to 12:00 p.m. and from 1:00 p.m. to 4:00 p.m. on weekends.



#### TAX DEDUCTIONS FOR EMPLOYEES WORKING FROM HOME

Two methods can be used to claim a deduction for certain home office expenses: the flat rate method and the detailed method. To use the detailed method, you will need to provide certain forms. You have until February 15<sup>th</sup> to request those forms. Read the memo (French only) to determine which method is best for you and to learn how to get the appropriate forms.

#### **MANDATORY N95 MASK**

In light of the <u>recommendation issued by the Institut national de santé publique du Québec (French only)</u> on January 25<sup>th</sup>, and considering the standards guide update from the CNESST made on February 9<sup>th</sup>, wearing an N95 mask is now mandatory when providing care within two metres of a user in a hot zone, or when two or more positive COVID-19 cases are gathered in a closed space.

This ministerial directive will come into effect on February 11<sup>th</sup> in every care setting as well as living environment. Fit test clinics: The CISSS is actively preparing a regional action plan to implement this new directive in its facilities and offer fit test clinics. The new clinics will be accessible for employees targeted by each direction. It should be noted that workers concerned by the directive who did not complete the fit test will still be able to wear an N95 mask in case of an outbreak.






### **HOOKED ON SCHOOL DAYS**

### **INCIDENT REPORT**

Any event, that is an unwanted, undesirable or feared situation that affected or could have affected a user's health, must be declared using the AH-223 report form.

When? As soon after noticing the event as possible, but better late then never...

**Who?** Any employee, intern, as well as anyone under contract who provides services to users on behalf of the establishment.

**Why?** Reporting an incident allows us to determine and analyze avoidable events in order to prevent reoccurrence and improve the quality and safety of care and services provided to users.

#### How?

- 1. AH-223 electronic form (ideally): You have a problem with your codes? Contact Caroline Roy at extension 452793 to create or reactivate your account.
- 2. AH-223 paper form: Send the form to your manager as quickly as possible.

### **LANGUAGE TRAINING**

McGill University offers an **English language training program** for the health and social services network. This program runs for 12 consecutive weeks and includes 24 hours of online courses with academic support and 16 hours of live courses. The objective of the program is to allow participants to act effectively and professionally with English-speaking users. The courses are **offered free of charge to employees working directly with the population and users**, for example, clinical workers and people working toward the reception, evaluation and orientation of users.

- ⇒ University-level training
- ⇒ Online courses with personalized academic support from a tutor
- ⇒ Eight levels of learning (elementary 1, 2, 3, intermediate 1, 2, 3 and advanced 1, 2)
- ⇒ Dynamic teaching and various learnings: individual, communicative and collaborative work
- ⇒ Priority given to oral comprehension and expression
- ⇒ 10 Continuous Education Units (CEU) for each level
- ⇒ About 5 to 7 hours of work per week including courses

Of course, you must get the authorization of your immediate supervisor before sending your application.



### **SKILLS TRAINING CERTIFICATE - HCAS**

Call for applications - Skills training certificate to become health care attendant in a CHSLD: the training course could be available across the whole territory if there are enough participants. You must express your interest in following this training course by February 28<sup>th</sup>, 2021.



**375-hour training course** (3 months).

**\$9,210 scholarship granted in three installments** for the duration of training (as long as you commit to work for the CISSS de la Côte-Nord for a year). This corresponds to a \$760 per week salary!

Training should start around mid-March across the territory if there are enough participants.
