ACQUISITION OF A PIECE OF LAND AND OF A PROPERTY FOR THE CONSTRUCTION OF THE MAISON DES ÂÎNÉS DE BAIE-COMEAU

The Centre intégré de santé et de services sociaux (CISSS) de la Côte-Nord is acquiring a piece of land and a property on Jalbert street in preparation for the construction of a seniors' home in Baie-Comeau.

Funded by the Québec Infrastructure Plan, this acquisition provides us with enough land area to build a seniors' home that will be coherent with the existing urban and architectural elements around the site. The residence will have 24 places for seniors and 24 places for adult users with specific needs.

ANNUAL REPORT OF THE ACTION PLAN REGARDING PEOPLE WITH DISABILITIES

The Board of Directors has adopted the 2019-2020 annual report of the 2018-2020 action plan regarding people with disabilities of the CISSS de la Côte-Nord, as well as the 2020-2022 action plan.

The annual report outlines certain actions that were carried out or that are under way, including:

- Implementation of a system to record the number of employees who have a disability (dating back to their hiring or developed during their employment).
- Adoption of a policy on the employment integration of people with disabilities by the Board of Directors on January 30th, 2019.
- Development of a procedure on the employment integration of people with disabilities (under way).
- Collaboration in the creation of a promotional video for the International Day of Persons with Disabilities in December 2020.

With its 2020-2022 action plan, the establishment continues its actions within these four areas of intervention:

- Employability of people with disabilities;
- Information, awareness, online access and available documents;
- Accessible procurement of goods and services for people with disabilities;
- Access to the establishment's facilities.



Each year, the CISSS de la Côte-Nord submits a report of the action plan regarding people with disabilities.

REPORT ON THE PLACEMENT UNDER CONFINEMENT IN AN ESTABLISHMENT

The report on the placement under confinement in an establishment was presented to the members of the Board of Directors. Placement under confinement is an exceptional legal measure to force a person to stay under surveillance, without their consent, in a facility of a health and social services establishment that is adequately equipped, thus depriving them of their freedom. Since this measure is a justified infringement on the person's rights and freedoms, it can only be applied in full respect for the applicable laws and regulations.

Between April 1st, 2020 and January 2nd, 2021, there were 96 prevention placements under confinement in the facilities of the CISSS de la Côte-Nord, including 46 at the Hôpital Le Royer and 36 at the Hôpital de Sept-Îles. During the same period, there were 40 provisional placements under confinement for a psychiatric assessment,
