ACTION PLAN REGARDING PEOPLE WITH DISABILITIES

The Board of Directors adopted the CISSS de la Côte-Nord's 2020-2022 Annual Report on the Action Plan Regarding People with Disabilities, as well as the 2022-2024 Action Plan.

In particular, the report outlines the work carried out to promote the integration of people with disabilities and eliminate the barriers encountered by them in our establishment, such as:

- The development of a tool to measure the number of employees with a disability
- The dissemination of the policy on the employment integration of people with disabilities
- A review of the staffing process to identify factors that could facilitate the employment integration of people with disabilities
- Awareness-raising internally and externally regarding the social participation of people with disabilities

In its 2022-2024 Action Plan, the CISSS will continue working on the following seven areas of intervention:

- Promotion
- Employability of people with disabilities
- Information, awareness and access to documents
- Accessible procurement
- Access to the establishment's facilities
- Adaptation to specific situations: emergencies, public health, civil protection
- Adaptation of any other activities that may have an impact on people with disabilities

SENIORS' HOME AND ALTERNATIVE HOME: ACQUISITION OF LAND IN HAVRE-SAINT-PIERRE

Administrators ratified the deed for the acquisition of land located on Copaco street in Havre-Saint-Pierre. With this acquisition, the CISSS de la Côte-Nord will be able to relocate its current home at 1004 Boréale street in Havre-Saint-Pierre.

This acquisition stems from the construction of the Maison des aînés et alternative de Havre-Saint-Pierre (a seniors' home and alternative home), which is currently underway. The residence will include 19 places for seniors, five places for alternative users and 24 places for clients of the Corporation des aînés de la Minganie.

The construction of a seniors' home and alternative home is also planned in Baie-Comeau. It will have 48 places, 24 for seniors and 24 for adults with specific needs.
