RECOGNITION OF FOUR ORGANIZATIONS IN THE PSOC

Four organizations of the region are now recognized in the Community organization support program (PSOC):

- Groupe accessibilité Saint-Augustin, organization involved with people with a physical or intellectual disability or with autism spectrum disorder.
- L'Arc-en-ciel, organization providing support and mutual aid to deal with grief (Baie-Comeau).
- Club Citoyens Seniors Rivière-Saint-Paul, organization to support the autonomy of seniors.
- Centre de dépannage du Parc Ferland, public health organization (Sept-Îles).

Note that the recognition of an organization does not automatically guarantee funding from the PSOC.

When an organization applies for recognition, a committee made up of the coordinator of the Table régionale des organismes communautaires de la Côte-Nord (TROC) and of the PSOC team of the Centre intégré de santé et de services sociaux (CISSS) de la Côte-Nord analyzes the applications and submits its recommendations to the Board of Directors.

To analyze the applications, the TROC appoints two representatives from community organizations and the PSOC team invites one professional from the concerned clinical direction of the CISSS de la Côte-Nord.

REPORT FROM THE PED ON THE ENFORCEMENT OF THE ACT RESPECTING END-OF-LIFE CARE

The report of the President and executive director on end-of-life care was presented during this public meeting. Among other things, it states that 20 requests for medical aid in dying were granted in the region between April 1, 2021 and March 31, 2022.

During this period, 326 people received palliative and end-of-life care at home, 276 people received these services in a palliative care hospice, 140 in a residential and long-term care centre (CHSLD) and 113 in the short-term care unit of a hospital.

Following the enactment of the Act respecting end-of-life care in December 2015, a report on the application of the policy on end-of-life care must be submitted each year to the Board of Directors and to the Commission sur les soins de fin de vie. 2022-2023 BUDGET OF THE CISSS DE LA CÔTE-NORD

The CISSS de la Côte-Nord is expecting a \$70 M deficit for the financial year ending on March 31, 2023. In order to return to a balanced budget, the CISSS continues its efforts to find solutions to the establishment's deficit with ministerial authorities.

On April 29, 2022, the ministère de la Santé et des Services sociaux (MSSS) informed each public establishment of the network of the initial budget envelope granted for 2022-2023. This takes into consideration, among other things, the indexation of the evolution of costs related to payroll and to the progression of staff in pay scales.

RESIGNATION OF AN ADMINISTRATOR OF THE BOARD OF DIRECTORS

Mr. Jean-Marie Vollant has announced his resignation as member of the Board of Directors of the CISSS de la Côte-Nord. He held the seat of independent member with youth protection expertise.

Procedures for the replacement of a resigning member provide that the Board of Directors acknowledge the resignation by adopting a resolution. Then, as provided by the act, the minister will appoint an independent member. The list of members of the Board of Directors is available on the [website](#) of the CISSS de la Côte-Nord.

The Board of Directors and the management of the CISSS de la Côte-Nord take this opportunity to thank Mr. Vollant for his involvement in the past years.

The Board of Directors of the CISSS de la Côte-Nord has 18 seats, including 9 reserved for independent members with various competency profiles.
