2023-2024 BUDGET OF THE CISSS DE LA CÔTE-NORD

The Board of Directors has adopted the 2023-2024 budget of the Centre intégré de santé et de services sociaux (CISSS) de la Côte-Nord. It is expecting a \$108 101 963 deficit, most of which is due to the cost of independent labour, which represents 35% of the payroll of the 2023-2024 budget.

In April 2023, the ministère de la Santé et des Services sociaux (MSSS) informed each public establishments of the network of the initial budget envelope granted for 2023-2024. It takes into consideration, among other things, the indexation of the evolution of costs related to payroll and the progression of staff in pay scales. A 3.2% indexation is also granted for expenses other than payroll.

In order to return to a balanced budget, the CISSS de la Côte-Nord continues its efforts with ministerial bodies to find long-term solutions. There were also concerted representations with other remote regions.

RENEWAL PROCESS FOR MEMBERS OF THE BOARD OF DIRECTORS

Following the introduction of Bill 15, an act to make the health and social services system more effective, the MSSS will not renew the mandates of independent members and members from the education community on the establishment's Board of Directors.
