CISSS DE LA CÔTE-NORD MANAGEMENT AND ACCOUNTABILITY AGREEMENT

The Board of directors adopted the 2023-2027 Management and accountability agreement of the CISSS de la Côte-Nord. Every year, the ministère de la Santé et des Services sociaux (MSSS) signs management agreements with its network institutions. The agreements identify the objectives to reach based on different indicators. The CISSS agreement contains over twenty indicators, namely:

- Retention rate of new hires;
- Percentage of employees who received training on Indigenous realities;
- Percentage of Secondary 3 students with full immunization coverage;
- Percentage of first interventions in youth protection assessment carried out within 14 days;
- Total number of persons receiving at-home support services;
- Average delay to be admitted to the emergency;
- Average length of stay by emergency room gurney patients;
- Number of surgeries on the wait list for more than one year.

The agreement is effective until the implementation of Santé Québec.

DOCTORS APPOINTED AS ACTIVE MEMBERS OR ASSOCIATE MEMBERS

Three new physicians are joining the staff at the CISSS de la Côte-Nord as active members, namely one pediatrician at Hôpital Sept-Îles and two general practitioners, one in Minganie and the other on the Lower North Shore. In addition, seven doctors have been appointed as associate members: one child psychiatrist, two psychiatrists, one haematologist-oncologist and three dentists. As associate members, these doctors will be able to work for the CISSS de la Côte-Nord at certain times.
